

AN ORDINANCE AMENDING SECTION 6A OF THE TOWN CODE
OF THE TOWN OF HILLSBOROUGH

THE BOARD OF COMMISSIONERS OF THE TOWN OF HILLSBOROUGH ORDAINS:

Section 1. Section 6A-14, Parking Prohibited at All Times, is hereby amended as follows:

“In accordance with section 6-24, parking is prohibited at all times along streets bounded with yellow curbing.” Is added as the first sentence of the section.

Section 6. All provisions of any town ordinance in conflict with this ordinance are repealed.


Section 7. This ordinance shall become effective upon adoption.
