

**NOTICE TO BIDDERS
TOWN OF HILLSBOROUGH, NC
ELIZABETH BRADY PUMP STATION REPLACEMENT

Sealed proposals will be received by the Town of Hillsborough, NC until **2:00 pm, Thursday, February 23, 2012** for the construction of **Elizabeth Brady Pump Station Replacement**.

The construction work will consist of the following approximate major quantities:

- Duplex submersible wastewater pumping station w/standby power
- Gravity sewer and forcemain

Proposals must be sealed and marked "**Elizabeth Brady Pump Station Replacement**". All proposals must be submitted upon the blank forms provided in the copies of Proposal, Contract and Specifications.

A Pre-Bid Conference will be held at **Town Barn, 101 E. Orange Street, Hillsborough, NC 27278** for all Bidders on **Thursday, February 16, 2012 @ 2:00 pm**. This conference is to allow Bidders an opportunity to present questions, obtain clarifications and inspect the project site. Attendance at the Pre-Bid Conference is recommended.

Each bid must be accompanied by Bid security in an amount of not less than five percent of the amount of the Bid. Security may be in the form of cash, a certified check made payable to Town of Hillsborough, NC and drawn on a bank or trust company insured under the Federal Deposit Insurance Corporation or a Bidder's Bond.

Contract Documents may be obtained directly from Duncan-Parnell at 4275 Regency Drive, Greensboro, NC 27410, 336-855-1211, or ordered online at dpibidroom.com, accompanied by a non-refundable deposit of one hundred dollars (\$100.00). Documents will be on file for viewing at the office of the Associated General Contractors, Raleigh, and Charlotte, NC; McGraw Hill Dodge may be viewed electronically on their website at <http://dodgeprojects.construction.com/>; HCAC/iSqFt. Plan Room, Raleigh, NC; the office of Town of Hillsborough Town Engineer, 101 E. Orange Street, Hillsborough, NC and the office of the Engineer.

The Bids for this proposed work will be received at the Town Engineer's Office, 101 E. Orange Street, Hillsborough, NC.

The public opening for this project will be held at **2:00 pm February 23, 2012**, at the Town Barn, 101 E. Orange Street, Hillsborough, NC, 27278.

Consideration will be given only to Bids of Contractors who are able to submit evidence showing that they are properly licensed under "An Act to Regulate the Practice of General Contracting", ratified by the General Assembly of North Carolina on March 10, 1925, and so subsequently amended.

Both Performance Bond and a Payment Bond are required in an amount equal to 100 percent of the contract price, conditioned upon the faithful performance of the contract and upon the payment in full to all persons supplying labor and furnishing materials for and in connection with the construction of the project.

The Town of Hillsborough has adopted a goal of 10% for participation by minority or women-owned businesses in contracts over \$100,000 awarded for construction by the Town. The Bidder shall comply with the requirements of North Carolina G.S. 143-128.

The Owner reserves the rights to waive any informalities or to reject any or all Bids and Proposals.

The Owner reserves the right to increase or diminish the quantities or items given in the Proposal and to award Contracts which appear to be in the best interest of the Owner.

Except as noted in the "Special Conditions" section of the Specifications, it is understood that this Contract may be increased in an amount equal to fifty percent of the total Contract as the Owner may option. It is further understood that any increases made may be in the total amount and each Bid item need not be increased in the same amount.

Each Contractor submitting a Proposal for this work, when requested, shall produce evidence of experience in constructing a project of similar size and nature. Contractors that are unable to produce this evidence may be rejected although they are low Bidders.
